



**Conditions for admission to the Master's degree study programme
Veterinary Hygiene and Ecology in English language
at the Faculty of Veterinary Hygiene and Ecology of the University
of Veterinary Sciences Brno for the academic year 2023/2024**

According to § 49 of the Act no. 111/1998 Coll., on Higher Education Institutions and on the Amendment and Supplement to Some Other Acts (the Higher Education Act), the Faculty of Veterinary Hygiene and Ecology of the University of Veterinary Sciences Brno (UVS Brno) publishes the conditions for the admission to studies in the Master's study programme Veterinary Hygiene and Ecology for the academic year 2023/2024.

Conditions for admission to the studies are:

- proper completion of full secondary education according to § 48 sect. 1 of the Act no. 111/1998 Coll., on Higher Education Institutions and on the Amendment and Supplement to Some Other Acts (the Higher Education Act), which the applicant submits by an officially verified document issued by the school departments of the regional authorities to the study department of the faculty,
- confirmation of the applicant's health fitness for study in a written form (medical certificate). This confirmation must be certified by a physician – a provider in the field of general practical medicine or practical medicine for children and adolescents (Appendix No. 1),
- the application to study and related appendices (in electronic form) have to be submitted the latest by the date April 30, 2023. In case the capacity of the study program is not fulfilled by the first term, the dean may announce another submission of applications for study. Deadline for the second round of application submitting is August 15, 2023.

The Faculty of Veterinary Hygiene and Ecology UVS Brno is setting, according to § 49 sect. 1 of the Act no. 111/1998 Coll., on Higher Education Institutions and on the Amendment and Supplement to Some Other Acts (the Higher Education Act), these further conditions for admission to studies:

- appropriate knowledge of biology and chemistry. This knowledge is verified by the entrance examination, which consists of entrance test in biology and chemistry based on the content of respective textbooks for secondary schools. The entrance test in biology has a form of a test, which consists of questions and multiple choice answers and questions that are to be answered in one or more words. The entrance test in chemistry has a form of a test, where the answer is a specific formula, chemical equation, scheme, drawing or solving an arithmetical problem. The biology entrance test contains a total of 37 questions; a correct answer is valued 1 point, thus the maximal result in the biology test is 37 points. The chemistry entrance test contains a total of 37 questions; a correct answer is valued 1 point, thus the maximal result in the chemistry test is 37 points. The maximal total number of points from both biology and chemistry entrance tests is thus 74 points. An applicant can not be accepted if he/she has acquired less than 10 points in the entrance test from biology or less than 10 points in the entrance test from chemistry. The duration of the

written entrance test from biology and the entrance test from chemistry together will not exceed 120 minutes.

- the admission procedure will be carried out in English language,
- based on a request and after providing a medical note (Appendix No. 2), student may be given an extension of time for writing the entrance exam.

For the academic year 2023/2024, the highest possible number of accepted students to the first year of study is determined at 24. The applicant can not be admitted to the study programme of the Faculty of Veterinary Hygiene and Ecology if he/she is already studying in this study programme. Admission to studies shall be decided on the basis of the order of the total number of points obtained within the admission procedure for the entrance examination.

The entrance examinations will be held in the period from May 22 to 31, 2023 (the first round) and from August 21 to 31, 2023 (the second round). Applicants will be informed in writing 14 days in advance. In case of serious reasons for which the applicant cannot come for the entrance examination in proper time, the dean may allow the applicant a substitutive term of the entrance examination. If the number of applicants who fulfilled conditions laid down for admission to studies will be less than 5, the study programme will not be opened. If the capacity of study programme is not fulfilled, the dean can announce alternative term of the entrance examinations no later than 15 days before this date.

The decision will be issued in writing form within 30 days from the verification of fulfilment of conditions for admission. Applicant may request a review of the decision within 30 days of its delivery. The applicant has the right to access the file at the faculty study department after notification of the decision.
